According to the International Monetary Fund (IMF), Indonesia's Gross Domestic Product (GDP) based on Purchasing Power Parity (PPP) has reached \$4.98 trillion, making it the world's eighth-largest economy. Key Challenges Faced by Expatriates and Companies in Indonesia

As Indonesia continues to attract foreign investment and international talent, expatriates and multinational companies face several challenges in navigating the country's evolving regulatory environment:

Taxation Concerns

Expatriates often face double taxation in both Indonesia and their home country. While Indonesia does offer specific tax facilities that can be utilized, such as the non-worldwide income tax treatment for up to 4 years for certain qualified expatriates, many foreign workers remain unaware of these benefits. All expatriates with tax residency status in Indonesia must fulfill their obligations by registering for a tax ID (NPWP), submitting annual tax returns, and making timely tax payments, regardless of their qualification for special facilities. Additional complexity arises when considering family members' tax status, as spouses and dependents may have different



residency determinations and income sources that require special attention. Issues like passive income from investments in home countries, rental properties, or compensation often create compliance challenges. Better understanding and utilization of existing tax relief mechanisms, including tax treaties and special provisions, would help companies attract and retain skilled foreign professionals while potentially enhancing Indonesia's appeal as a work destination.

Immigration Regulations

Securing work and stay permits remains time-consuming despite government efforts to streamline immigration procedures. Many companies still face challenges with compliance requirements and administrative processes, while changing implementation practices can complicate workforce planning. Strengthened immigration enforcement measures require businesses to maintain rigorous compliance with visa and work permit regulations, in line with Indonesia's efforts to protect its labor market and ensure legal compliance.

Regulatory Adaptability

Policy changes, sometimes implemented with limited notice, pose planning challenges for foreign businesses. For example, the introduction of a 10-year stay permit for qualified investors and professionals in Indonesia's new capital (IKN) highlights the need for businesses to stay informed and adaptable.

Additionally, navigating Indonesia's religious and cultural landscape presents challenges, from



understanding prayer times and religious holidays to adapting to local business etiquette and appropriate dress codes. Language barriers can further complicate even routine interactions.
